Request motion to approve the "Christopher Grymko and Jeanne Grymko vs. Luzerne County Flood Protection Authority", IN REM No. 2019-08255, settlement in the amount of \$37,500.00.

Request motion to approve the terms provided by FNCB Bank, 102 East Drinker Street, Dunmore, PA 18512-2491, to finance the building purchase and interior renovations at 1989 Wyoming Avenue, Forty Fort, PA.

On the question:

**Mr. Hardwick:** wanted to reiterate the factual information so we are clear if the Authority intends to work with FNCB Bank. The Authority will borrow \$715,000 total, building cost \$565,000, minimum \$20,000 down and it's a 25-year term. Wanted to reflect in the minutes because it is different than what was discussed at last month's meeting.

**Mr. Yannuzzi:** In their proposal, FNCB Bank is requiring us to have a deposit relationship for the life of the loan. The minimum balance requirement would be 140% of the outstanding loan balance (\$1,000.000.00). The interest rate on the deposit account would be .125%. We need to work out some kind of wording that with our funds at FNCB that the interest rate needs to be competitive with the market. The Executive Director is going to reach out to FNCB and push back on the deposit relationship amount.

Mr. Hardwick: So, you are saying that is a contingency?

**Mr. Yannuzzi:** Yes, FNCB has to agree they are going to be competitive, let them know we agreed to go with them, but they need to match what we are getting now or best rates from other banks. If not, we are going to have to negotiate something.

**Mr. Hardwick:** Last question, what is the timing? I am going to be honest I am just a little nervous about moving the operations fund over there without them formally agreeing.

Mr. Yannuzzi: There's a contingency.

Mr. Hardwick: If that's the contingency then I am OK but let's make sure the motion is clear on that.

**Mr. Yannuzzi:** Yes, we are going to move it over just as long as they match what we are getting now and competitive in the future when we ask for other rates in the industry.
